REQUIREMENTS FOR SOCIAL VISA

(Note: Only for Ex-Myanmar Citizens and Immediate Family Members of Myanmar Citizens)

1. **ONE** completed Application form (Application for Social Visa Form)
2. **ONE** completed Work History form
3. **Name / Business Card** of the applicant
4. **ONE** completed biography form
5. **Application Letter** addressed to the Ambassador
6. **Proof of Ex-Myanmar citizenship**, either a copy of NRC or a copy of proof document mentioning relationship with Myanmar Nationals relatives
7. If you are a dependent, provide the details of the person you depend on.
8. Parents' Guarantee Letter and passports copies are needed if their children apply for the visa separately.
9. **Original Passport** with at least 6 months validity and available visa pages.
(Non-South African passports need to provide stay permit or documents showing legal status in RSA)
10. **TWO** recent colour photo with white background (35 mm x 45 mm).
One photo should be glued to the Visa Form.
11. **ONE** photocopy of the information page of the passport
12. Photocopy of Myanmar Visa Sticker(s) approved previously (if applicable)
13. Applicants may be asked to provide other documents if and when necessary.

VISA INFORMATION

1. The stay for the Social Visa is exactly 70 days, which is extendable.
2. The validity of the Social Visa is 3 months from the date of issue, which CANNOT be renewed or refunded.
3. The first times visitors for social purpose are NOT eligible to apply for the Multiple Entry Journey Visa. MJEV application will be approved on case by case basis.
4. Embassy will issue visa for completed applications as soon as receive it. Embassy will not take any responsible for too early and too late applications.

1. The photograph must have been taken within the last six months.
2. The photograph should be in colour with the white background and of the size of 35 mm x 45 mm.
3. The photograph must be a full-face view in which the visa applicant is facing the camera directly. Side or angled views are NOT accepted.
4. Digitally printed photos should be produced without visible pixels or dot patterns. Fine facial features should be discernible.
5. **Photocopied photographs are NOT accepted.**
